  - That the appointee is married or unmarried etc. In the former case it has to be further declared that the appointee has only one living spouse. In case the appointee is a woman, the appointee shall declare that she is not married to a person who already has another living wife.
  - That he/she was not convicted or sentenced by any court of Law 2. in any criminal case.
  - That at present, no criminal/vigilance case is pending against 3.
  - 4. That his/her services have never been dismissed/removed by any State/Central Government.
- A set of self-attested copies of all the documents regarding the qualification, date of birth etc.
- If at any stage the statement/documents submitted by the appointee is found to 16) be false, fabricated, misrepresented, suppressed or any of the contents concealed, then the services shall be terminated without any notice and legal action will be initiated.
- The appointee shall join within the period specified in the order of appointment 17) or within such period as may be extended from time to time by the appointing authority subject to a maximum of four months from the date of order of appointment. The order of merit shall not be disturbed as provided in Rule 8 of Punjab Civil Services (General and Common Conditions of Service) Rules 1994.
- 18) If the appointee has not passed Matriculation Examination with Punjabi language as one of the compulsory or elective subjects or any other equivalent examination, as specified by the Government from time to time, then same shall be passed within a period of 3 years from the date of appointment to the services.
