1. The post you are appointed on is Temporary, but likely to continue.

Your services will be governed by the Punjab Medical Education Service (Class-I) Rule, 1978 amended upto 1985 and Punjab Civil Services (General and Common Conditions of Services) Rules, 1994 and subsequent amendments.

In case you were not in regular Government service, your appointment is subject to your character and antecedents verification from the District Authorities. In the event of these being found unsatisfactory your service shall be terminated without any notice.
