- 3.d. "15% seats shall be open to candidate who have studied 10+1 and 10+2 examination or equivalent examination with Physics, Chemistry, Biology and English as regular students from a recognized institution from any where in the country. However, if the requisite numbers of eligible qualified candidates are not available under 85% quota, the vacant seats shall be transferred to 15% quota and vice versa."
