On careful consideration of the proposal, the Government of Punjab has decided to issue "No Objection Certificate/Essentiality Certificate" to the applicant for BAMS course with 60 seats.

It is certified that:-

- (a) It is desirable to give permission for 60 seats of BAMS course in public interest.
- (b) Starting BAMS course at Saraswati Ayurvedic Hospital and Medical College, V.P.O-Gharuan, Tehsil Kharar, Distt. Mohali (Pb.). It is also certified that adequate clinical material as per norms of Central Council of Indian Medicine is available with proposed/existing medical college. It is further certified that in case the applicant fails to create infrastructure for the Ayurvedic college as per Central Council of Indian Medicine norms and fresh admission are stopped by the Central Government, the State Government shall take over the responsibility of the students already admitted in the college with permission of the Central Government.

Conditions:-

- (i) The Institute will get affiliation with the concerned university before making admissions.
- (ii) The Institute will obtain recognition from the Central Council of Indian Medicine, New Delhi.
- (iii) No admission shall be made without the prior approval of Punjab Government for which the institute would make a separate application after putting up the requisite infra-

Structure and recognition / affiliation from the Council / University.

- (iv) The admission shall be done as per criteria fixed by Punjab Government from time to time.
- (v) The reservation of seats shall be as per Punjab Government instructions issued from time to time.
- (vi) The pay and emoluments of the staff shall be as per Punjab Government pay scales.
- (vii) The inspection of the Institute shall be carried out on yearly basis upto the completion of the study of first batch of the students. Thereafter, the inspection shall be periodical, after three years.
- (viii) The project is to be implemented as per the approved project report within the prescribed time.
- (ix) The Punjab Government will have the right to withdraw the Essentiality Certificate if the society fails to meet any of the conditions of Essentiality Certificate.
- (x) The construction work shall be completed with in one year and admission shall be made with in two years of the issue of N.O.C.
- (xi) The validity of the NOC will be of two years.
